Sir,

This has reference to your letter No. IITM/2024/6281 dated 10.10.2024 on the subject cited above.

In this connection, it is to inform you that your request regarding disaffiliation/closure of College i.e IITM College of Science, Art and Commerce, Karnal Road (NH-44), Murthal, Sonapat has been considered by the Vice-Chancellor for/from the session 2025-26. The Academic Council vide Reso No.91 dated 13.12.2024 has resolved as under:

"Resolved that the request of the Chairman, IITM College of Science, Arts and Commerce, Karnal Road, (NH-44), Murthal, Sonapat as above be recommended to the Executive Council for consideration and approval."

Further, the above recommendations of the Academic Council have also been approved by the Executive Council vide Reso. No.17 (43) in its meeting held on 30.01.2025 (copy enclosed) with the following conditions:-

- a) In the case of discontinuation of the college, it shall be incumbent upon the governing body of the institution concerned to give a notice of one year to its employees regarding termination of the services, which will taken effect only if and when the permission is granted by the University and subject to the condition, if any imposed by it.
- b) The discontinuation in respect of college shall be in stages/phase manner as under:
 - I) In the first year, admission to Part-I class will be discontinued and admission for Part-II, III will continue
 - II.) In the 2nd year, admission to part-II class will be dis-continued and admission for part-III if any, will continue.
 - III) In the 3rd year, there may be no admission.
