- 17(37) 1. Ratification of the action taken by the Vice-Chancellor in approving the minutes of the meeting of the Faculty of Interdisciplinary Studies of its meeting held on 26.06.2024 regarding Eligibility Conditions, Mode of Admissions, Sanctioned Intake and Curriculum Framework and Ordinance for 4-Year UG Program in Public Health w.e.f the session 2024-25 offered by the University Institute of Public Health (Annexure A/87 pages 726-730, already circulated).
2. Consideration of the recommendation of the Faculty of Interdisciplinary Studies made vide Reso. No. 3 of its meeting held on 04.12.2024 regarding change of nomenclature of 4-Year UG Program in Public Health to Bachelor in Public Health Sciences with minor modifications in Eligibility Conditions, Mode of Admissions, Sanctioned Intake and Curriculum Framework and Ordinance of the Program w.e.f the session 2024-25 (Annexure A/88 pages 731-733, already circulated).

On the recommendation of the Board of Studies in UIPHS of its meeting held on 21.06.2024, the Faculty of Interdisciplinary Studies vide Reso. No. 3 of its meeting held on 26.06.2024 recommended the eligibility conditions, Mode of Admission, Sanctioned Intake and Curriculum Framework and Ordinance of 4-Year UG Program in Public Health w.e.f the session 2024-25 offered by the University Institute of Public Health. The Vice-Chancellor approved the recommendations of Faculty of Interdisciplinary Studies in anticipation of the approval of the Academic Council.

After that on the recommendations of the Director, UIPHS, the Vice-Chancellor approved the modifications in the eligibility conditions, sanctioned intake of Bachelor in Public Health Sciences w.e.f the session 2024-25. The Board of Studies of UIPH of its meeting held on 14.11.2024 considered the action taken by the Vice-Chancellor regarding modifications in eligibility conditions, change of nomenclature of the program and sanctioned intake during 2024-25 admissions and approved the same. The Board of Studies vide reso. No. 2 also approved the Curriculum Framework and Ordinance, Scheme of Examinations and Syllabus for the BPHS Program as approved earlier in BOS meeting held on 21.06.2024 without any change (**Annexure A/89 pages 734-779, already circulated**). The Faculty of Interdisciplinary Studies in its emergent meeting held on 04.12.2024 considered the recommendations of the Board of Studies of UIPHS dated 14.11.2024 regarding change of nomenclature of the Course, revision of Eligibility Conditions, Mode of admissions, Sanctioned Intake during the session 2024-25 with minor modifications and recommended to the Academic Council for approval. Further, the Faculty of Interdisciplinary Studies resolved that the Ordinance and Credit Framework for Bachelor in Public Health Sciences (BPHS) w.e.f the session 2024-25 be recommended to the Academic Council for approval.

The matter has been considered by the Vice-Chancellor, who has ordered to place the same before the Academic Council for ratification/approval.

The Academic Council vide Reso. No. 78 in its meeting held on 13.12.2024 considered the above and passed the following resolution:

RESOLVED THAT THE ACTION TAKEN BY THE VICE-CHANCELLOR AS AT 1 ABOVE BE RATIFIED AND RECOMMENDED TO THE EXECUTIVE COUNCIL FOR CONSIDERATION AND APPROVAL ALONGWITH RECOMMENDATIONS OF THE FACULTY OF INTERDISCIPLINARY STUDIES AS AT 2 ABOVE.
