17(36) Consideration of the Minutes of the Meeting of Centre for Curriculum & Design Development Officials held on 12.11.2024 & 13.11.2024 regarding proposing four credit course on "Community Engagement & Service" for UG and PG students of University Teaching Department/Institute/Centre & affiliated colleges of the Maharshi Dayanand University, Rohtak w.e.f. 2024-25 (Annexure A/86 pages 713-725, already circulated).

A meeting of Centre for Curriculum and Design Development (CCDD) officials was held on 12.11.2024 & 13.11.2024. The Committee deliberated over the proposal received from the Director, University Outreach Programme regarding proposing four credit course on "Community Engagement & Service" for UG and PG students of University Teaching Department/Institute/Centre & affiliated colleges of the Maharshi Dayanand University, Rohtak w.e.f. 2024-25 and recommended that:

1. The course structure may be amended (Annexure-"A") in view of the 'Guidelines for Fostering Social Responsibility & Community Engagement in Higher Education Institution in India 2.0' duly issued by the University Grants Commission.

2. The course will be of four (04) credits (01 credit for theory, 01 credit for field work and 02

credits for filed project)*

3. Formative assessment methods (as suggested in Annexure) may be adopted. The Institution will be responsible for keeping the record of the assessment.

4. The course may be offered at:

a) UG level as an alternative to internship or as Value Added Course

b) PG level as a Value Added/Skill Enhancement.
