As Head of Community Medicine Department developed MD(Community Medicine) course curriculum in 1996 which has been adapted and implemented in many medical colleges in India; established first

School of Public Health in 2004 in a Medical Institute of India which is now recognized as a premier hub of public healtheducation & research in India. Initiated MPH program in 2007 and BPH in 2019and planned MD program in Family Medicine, Fellowship Programs in Health Economics, Environmental & Occupational Health, and Public Health Informatics.

Served as Temporary Advisor to WHOon Mother and Newborn Information for Tracking Outcomes and Results (MoNITOR), Epidemiology, Non-Communicable Diseases (NCDs), Verbal Autopsy, and Public Health. #### **Major Research Contributions:**

Using community-based surveys, conducted in 1990s, advocated for initiation of healthy heart project in about one million population of Chandigarh which involved surveillance, development of guidelines, training of medical and paramedical personnel, and coordination with several stakeholders. After 3-year implementation, the project evolved into Chandigarh Non-Communicable Diseases (NCD) Prevention and Control Program which is one of the first NCD control program in India funded and implemented by the government. Development and implementation of Rheumatic Heart Disease Control Program in about one million population of district Ropar in Punjab has also been adopted by the government for country-wide implementation.

Research & development of verbal autopsy tools to measure cause specific mortality is now implemented by Registrar General of India in the National Sample Registration System. Cause specific mortality statistics generated from this initiative has helped in planning and evaluation of national rural health mission. Several national studies for assessment of the impact of targeted preventive interventions on HIV infection have led to intensification of targeted HIV prevention programs resulting in a substantial decline of HIV in India.

In the last five years, developed a low-cost Integrated Health Information System for primary health care using open source and free software which can be adopted by Digital Health Mission of India for nationwise application. Established disease burden for vaccine preventable diseases, and evaluated NHM.
