Note:

1. Final cut off date for admission is 30.08.2025 and, thereafter, no admission shall be made by the Department/College/Institute so as to complete the required teaching days in a semester as per University norms.
2. It shall be the responsibility of the concerned Head/Director/Principal to arrange extra classes for such students who are admitted with late fee as per above mentioned schedule.
3. The Heads/Directors/Principals of the Departments/Colleges/Institutes are requested to inform the students well in time by displaying the schedule on the notice boards etc.
4. The late fee as charged from the students in the affiliated Colleges/Institutes shall be remitted to the University alongwith the Continuation Return.
5. The admission schedule for those Programs where the admissions are made by the State/Central Govt. agencies, the admission schedule shall remain same as made applicable by those agencies.
