### **2. Enhanced Safety Measures**


- Visitor entries will be restricted and recorded in a Visitor Register at the main gate. Details such as name, address, entry/exit time, and vehicle information will be noted.

- 3. Infrastructure Maintenance**
- Maintenance issues like sanitation, drinking water, and repairs etc. will be addressed promptly.
  - Dr. Vijay Rathee will coordinate all maintenance activities, supported by reports from staff members.
- 4. Mandatory Student ID Cards**
- Students are required to carry their ID cards at all times. Entry without an ID will not be permitted.
- 5. CCTV Surveillance**
- Additional CCTV cameras will be installed to enhance campus safety. The camera from the Director's Office will be relocated to the main entrance.
- 6. Dress Code Implementation**
- Law students will adhere to an advocate dress code.
  - A dress code for management students will be finalized soon, with formal attire required five days a week. Wednesdays will allow casual wear, though students are advised to dress appropriately.
- 7. Secretary Appointment**
- Dr. Anupam Kulwal was appointed as the Secretary of the Staff Council and will prepare the minutes of future meetings.
- 8. Republic Day Celebration**
- The MDU-CPAS family will celebrate Republic Day, with Dr. Snehlata Sangwan organizing the event. The best NCC cadet will be honored with medals and certificates for outstanding performance.

### Conclusion


The resolutions were unanimously agreed upon, and it was decided to review progress in the next meeting.
