10(43) Consideration of the recommendations of the committee constituted by the Vice-Chancellor to consider the requests of research scholars regarding publications for submission of Ph.D. Thesis (Annexure A/131 page 788, already circulated).

The Vice-Chancellor constituted a committee comprising of following to consider the requests of research scholars regarding publications for submission of Ph.D. Thesis in light of UGC notifications dated 11.02.2025 and 16.07.2025:

1. Prof. S.C. Malik, Dean Academic Affairs - Convener
2. Prof. Narasimhan B., Director (IQAC)
3. Prof. Harish Dureja, Dean (R&D)

The Committee considered the requests of research scholars regarding publications for submission of Ph.D. Thesis in light of UGC notifications dated 11.02.2025 and 16.07.2025 and recommended as under:

1. Ph.D. student shall publish a minimum two research papers, one of which may be a review paper (at least one should be published and other may be in press/accepted) out of his/her research work. These papers should be in Scopus/Web of Science indexed/UGC CARE listed journals (upto 10.02.2025) / peer-reviewed journals. The research scholar shall preferably be first author and supervisor/co-supervisor/research guide may be the corresponding author in at least two research papers. In addition, a research scholar will make two paper presentations in conferences/seminars before the submission of the thesis. The proof of publications and paper presentation must be appended with the thesis.
2. The publications prior to 10.02.2025 should be in the journals as prescribed in the respective Ordinance and after 10.02.2025 may be in Scopus/Web of Science indexed/ peer-reviewed journals.

The Academic Council vide Reso. No. 73 in its meeting held on 02.09.2025 considered the above and passed the following resolution:

RESOLVED THAT THE RECOMMENDATIONS OF THE ACADEMIC COUNCIL AS ABOVE BE APPROVED.

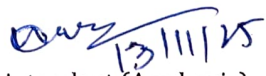

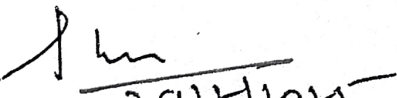

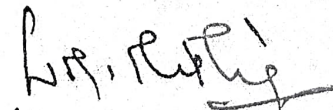

The Committee revisited the requirement of publications based on the requests of research scholars admitted under various Ph.D. Ordinances in light of UGC notification dated 11.02.2025 and 16.07.2025 and recommended the following:

1. Ph.D. student shall publish a minimum two research papers, one of which may be a review paper (at least one should be published and other may be in press/accepted) out of his/her research work. These papers should be in Scopus/Web of Science indexed/UGC CARE listed journals (upto 10.02.2025) / peer-reviewed journals. The research scholar shall preferably be first author and supervisor/co-supervisor/research guide may be the corresponding author in at least two research papers. In addition, a research scholar will make two paper presentations in conferences/seminars before the submission of the thesis. The proof of publications and paper presentation must be appended with the thesis.
2. The publications prior to 10.02.2025 should be in the journals as prescribed in the respective Ordinance and after 10.02.2025 may be in Scopus/Web of Science indexed/peer-reviewed journals.
