Sir/Madam,

In continuation to this office letter No's CB-IV(C)/2025/10802-5 dated 05.08.2025, CB-IV(C)/2025/10806-9 dated 05.08.2025 and CB-IV(C)/2025/10810-13 dated 05.08.2025 vide which it was notified that the Vice-Chancellor, in anticipation of approval of the A.C./E.C. has waived off the penalty of Rs. 2,50,000/- which was imposed by the A.C./E.C. vide Reso. No. 72 dated 13.12.2024 and Reso. No. 17(32) dated 30.01.2025 respectively for not constituting the Governing Body upto 30.04.2025.

Accordingly, I have been directed to inform you that the action taken by the Vice-Chancellor, in anticipation of approval of the Academic Council/Executive Council with regard to waive off the penalty of Rs. 2,50,000/- has been considered by the Academic Council/Executive Council vide its reso. No. 60 dated 02.09.2025 and resolved as under (copy enclosed):-

xx xx xx THE MATTER WITH REGARD TO WAIVING OFF THE PENALTY OF RS. 2,50,000/- BE KEPT IN ABEYANCE AND THE SOCIETY BE ASKED TO CONSTITUTE THE GOVERNING BODIES OF THE CONCERNED GOVT. AIDED COLLEGES UPTO 31.12.2025. THE HOUSE FURTHER RESOLVED TO RECOMMEND THE SAME TO THE EXECUTIVE COUNCIL FOR APPROVAL.





other than the members nominated by competent/ex-officio i.e. Principal, as the case may be, consisting of not less than three and not exceeding 21 members. The office bearers shall comprise of the President, Vice-President, Treasurer, General Secretary and Secretary. The first four shall be elected by the General Body or the Collegium of the Society/Trust/a private limited non profit company registered under section 8 under the new Company Act 2013 or under section 25 as per old Company Act 1956, running the College/Institute. The Principal shall be the ex-officio Member- Secretary of the Governing Body. Of the remaining sixteen members 11 shall be elected by the General body or the Collegium of the Society/Trust/ a private limited non profit company registered under section 8 under the new Company Act 2013 or under section 25 as per old Company Act 1956, one shall be nominated by the University, one by the State Govt., and three shall represent the staff by election (Annexure A/129 pages 932-935, already circulated). Further, the Vice-Chancellor has also appointed University Nominee(s) on the respective college upto 05.07.2027, Rohtak.

After the expiry of last date i.e. 31.12.2023 for constituting the Governing Body/Board of Governors by the colleges/institutes, the cases of the Colleges/Institutes where Governing Body/Board of Governors was not constituted were referred to the Committee already constituted by the Vice-Chancellor to examine the matter regarding non-compliance of University provisions by the Colleges/Institutes. The Committee in its meeting held on 09.10.2024 under heading Govt. Aided & SFS colleges where the election of the Society has been conducted but the election of College Governing Body is pending recommended in respect of Colleges falls under Jat Education Society, Rohtak that the Colleges may be given time upto 30.04.2025 failing which they may be imposed penalty of Rs. 2,50,000/- as per E.C. Reso. No. 39 dated 31.12.2021. The said recommendations were considered by the A.C./E.C. and approved the same vide Reso. No. 72 dated 13.12.2024 and Reso. No. 17(32) dated 30.01.2025 respectively (Annexure A/130 pages 936-939, already circulated and Annexure A/131 pages 940-944, already circulated).

Accordingly, this office vide letter(s) dated 14.02.2025 and reminder letter dated 01.04.2025 asked the concerned Colleges to complete the process of constitution of Governing Body/Board of Governors upto 30.04.2025 failing which a penalty of Rs. 2,50,000/- will be imposed (Annexure A/132 page 945, already circulated and Annexure A/133 page 946, already circulated). Further, this office vide letter No. CB-IV-C/2025/9840-44 dated 17.07.2025 (Annexure A/134 page 947, already circulated) directed to all the Principal(s) of Colleges which falls under the aegis of Jat Education Society, Rohtak to deposit the penalty of Rs. 2,50,000/- for not constituting the Governing Body/Board of Governors upto 30.04.2025 as per E.C. Reso. No. 39 dated 31.12.2021 immediately.
