Resolutions No. 17 dated 12.06.2014, Reso. No.122 dated 29.06.2016, Reso. No. 4 dated 04.09.2019, Reso. No. 50 dated 29.07.2020 & Reso. No. 10 dated 04.06.2021 as under:

prior to travel date or give her/his consent to publish one publication within one year after his/her return, failing which she/he may be asked to refund the amount.

consultancy project of minimum 5.0 lakh (completed or ongoing), or research project of minimum 5.0 lakh (completed or ongoing) in the last two years prior to the travel date OR give undertaking to publish two publications in SCOPUS/Web of Science or fetch consultancy project of minimum 5.0 lakh OR research project of minimum 5.0 lakh within two years after his/her return. failing which she/he be may asked to refund the amount. For subjects where SCOPUS/ WoS listed journals are not available/ lesser in number, in that case the publications in Peer Reviewed and Referred Journal (after 10.02.2025) will be considered. In the case of nonscience subjects, the faculty member may be allowed on the basis of one book publication or two chapters in two different books published by international publisher in the year prior to travel date OR give her/his consent to publish. However, in exceptional circumstances Vice-Chancellor may relax the above based mentioned conditions outstanding work by the faculty member. in case the above conditions are not met.

The payment of daily allowance will No Change be made at Govt. of Haryana rates and D.A. will be paid for the duration of the conferences plus four days i.e. two days before and two days after the conference which will include the travel period if the journey period is less than two days before and two days after then actual DA will be given for the actual journey days, which shall be maximum two days.

Persons selected for participation should travel by excursion tickets in sectors by the cheapest air ticket by any air line (in any case not exceeding Air India Fare). Actual fare not exceeding A.C. Class-II Fare will admissible for travel from University/College Head Quarter to

the nearest Airport and back.

However, taxi fare for travel upto the airport from the Head Quarter may be allowed by the Vice-Chancellor on the basis of entitlement.
