- 1) The Applicants/bidders have to complete 'Application / Bid Preparation & Submission' stage on scheduled time as mentioned above. - 1. Every e-tender shall be accompanied by the **Earnest Money 36,000/- (Fixed)** and **Rs.2000/- as tender fee** and **Rs.1180/- the e-service fee** should be deposited **through online mode only**.
- 2. The e-tender received without earnest money or after the due date shall not be entertained except with the special approval of the competent authorities.
- 3. The e-tenders shall be opened in the office of HOD (Genetics), M.D. University, Rohtak on 30.10.2025 at 11:00 a.m. by the Purchase Committee. The quotes or their authorized representatives are allowed to attend the meeting of the Tender Opening Committee at their own costs.
- 4. The goods shall be supplied by the Supplier within the time limit specified in the supply order. In case, the material is not supplied within the delivery period, the supplier shall be liable to pay the University the compensation amount equivalent to 1% (one percent) of the cost of material each day or such other amount as the CPC/Asstt. Registrar (P&S) may decide till the supply remains incomplete, provided that the total amount of compensation shall not exceed 10% (ten percent) of the total amount of the cost of material supplied. Appeal against these orders shall, however, lie with the Vice-Chancellor, M.D. University, Rohtak whose decision shall be final.
- 5. The following charges and terms may be spelt out in your offer clearly:

- 11. The quantity of material/supplies shall be subject to increase or decrease on the tendered rates. This increase or decrease shall be communicated by the University within 180 days of acceptance of the tender.
- 12. Supplies shall be made as per the schedule and within such time as is indicated in the supply order.
- 13. The rates accepted by the University shall be applicable up to 180 days and the supplier shall have to make supply during the period as and when required.

- 14. The University is situated within the Municipal Limits. As such, Octroi, if any, shall be payable. In case, the material is supplied through a Transport Company by road, the Transport Company's charges, labour charges and octroi charges shall be borne by the supplier. It may be mentioned specifically as to whether the material will be sent by rail or by road through a Transport Company.
- 15. Guarantee/warrantee of items must be mentioned.
- 16. The University is registered with the Department of Scientific & Industrial Research, Ministry of Science & Technology, New Delhi in terms of Govt. Notification No. 10/97-Central Excise dated 1 March, 1997 and Notification No. 51/96-Customs dated 23.7.1996 vide Registration No. TU/V/RG-CDE(244)/2020 dated September, 18,2020upto 31-08-2025. Thus the University is exempted from payment of Custom Duty and Excise Duty. The consignee shall issue necessary certificates duly countersigned by the Registrar, M.D. University, Rohtak to avail of exemption.
- No tender documents will be issued separately and rates are to be offered on company's letter pad.
- 18. If a holiday occurs on the opening day, the tenders will be opened on the next working day.
- 19. The packing, forwarding, freight, insurance charges etc. may be quantified in terms of amount. These charges will not be payable against such vague statement as "packing, forwarding, freight and insurance charges etc. extra".
- 20. # Specifications of Real-time PCR Machine (Bio-Rad, Applied Biosystem, PerkinElmer, Thermoscientific, Agilent)

## Specifications-

## **Technical Specifications**

It should be able to do both Real-time PCR and post-PCR analysis automatically.

It should be able to use chemistries including SYBR green, evagreen, fluorescent labelled hydrolysis probe etc. The system should be capable to perform dye-binding thermal shift assays for protein unfolding analysis.

- System should run real-time PCR experiments without being attached to a computer (Touch screen). When operated as a stand-alone instrument, the instrument should save at least 1000 run files.
- Block: It should be 96-well with Peltier based heating and cooling mechanism.
- System should be able to perform automatic Gene expression, SNP, allelic discrimination, dissociation curve analysis, Competitive allele specific PCR with biallelic scoring analysis (KASP Analysis), HRM analysis (with minimum of two user license) as well as pathogen detection. Gene expression analysis by relative quantity (ΔCt) or normalized expression (ΔΔCt), ANOVA, t-Test, multi plate analysis and end point analysis etc.
- System should be enough sensitive to detect even 1.3-fold to 1.5-fold change in gene expression.
- System should have true gradient capability (8 temperature gradient or more) with identical hold times for all rows of the gradient or similar better technology.
- Peltier-driven block with ramping speed of 5°-6°C or more per second, with an average ramp rate of more than 3.3°C/sec.
- Sample block temperature accuracy is +/-0.2°C of programmed target at 90°C, with a uniformity of +/-0.3°C well-to-well within 10 seconds of arrival at 90°C.
- Optics independently illuminate and detect fluorescence from each well with the same LED/detector pair per channel. The system should have six filtered LEDs for illumination and differentially detect emission using six filtered photodiodes/CMOS (one for each channel plus FRET). Multiplex amplification and melt curve and end-point analyses should be performed on up to six fluorophores in a single reaction well.
- Absorption spectra in the 450–680 nm; Emission spectra in the 515–730 nm range.
- One channel should be dedicated for FRET and Protein Thermal Shift (Protein Melt)

experiments.

- The real-time system should be compatible with all kinds of plastic consumables and reagents and capable of running various chemistries like TaqMan, SYBR green, FAM, HEX, etc.
- Should detect ≤10 fmol of fluorescein.
- System should be able to integrate with an automation system for hands-free operation.
- System should continue to run and complete a run if the software is stopped or interrupted to prevent run data from being list in case if there is unintentional interruption of the software.
- Provide a list of customers with contact details & email address and performance certificates.

  The equipment will be considered after getting satisfactory report from them.
- The system should be IEC & CE certified.

## Additional software specifications

- PCR quantification by standard curve features automated calculations of reaction efficiencies with y-intercept.
- Multiple reference genes could be assigned in normalized expression ( $\Delta\Delta$ Cq) analysis.
- Software should have reference gene selector tool displays gene stability for selection of ideal reference genes.
- Up to 5,000 Cq values from different data files should be compared for gene expression analysis.
- Image export options must include dpi selection up to 600dpi, choice of any image size, and color selection using RGB specifications.

System should come with startup consumables i.e. 50 qty of 96 well plates and 100 sealers, 2ml syber green master mix. The system must offer pre-programmed assays for easy selection of calibrators (the machine should not require regular calibration), normalizers and sample associations. (System calibration either should not require or should come with three free calibrations if required including the cost of consumables if any required for calibration)
