Copy of extract of Rego. No. 10/321 of the meeting of
the Executive Council held on 29/09/2025

- 10(32) To report the action taken by the Vice-Chancellor in placing Sunil Gugnani Memorial College of Education for Girls, 1628/4, Rajindera Colony, Bhiwani Chungi, Rohtak - 124001 in No Admission Category for admission to B.Ed. regular course for the session 2025-26.

Upon considering the request of the President, Sunil Gugnani Memorial College of Education for Girls, #1628/4, Rajindera Colony, Bhiwani Chungi, Rohtak - 124001 dated 26.07.2023 extension to submit permission of the NCTE for shifting of College premises/to grant permission to B.Ed. course for the session 2023-24 (Annexure A/94 page 698, already circulated), the Vice Chancellor ordered to refer the said request to the three members Committee dealing with Colleges matter(s). Accordingly, the meeting of the committee was held on 09.08.2023 and submitted its Proceedings (Annexure A/95 page 699, already circulated). As per recommendations of the committee duly approved by the Vice-Chancellor in anticipation approval of Academic/Executive Council, the above College was granted time up to 30.06.2024 for submission of NOC for shifting of premises from the NCTE and was also put under "Admission Category" for the session 2023-24 subject to completing the following conditions:

- a) That the President, Sunil Gugnani Memorial College of Education Society(Regd.) Rohtak shall submit the permission of the Apex Body i.e. NCTE to the University up to 30.06.2024.
- b) That if the College fails to submit the NOC from NCTE regarding shifting of premises to its new location up to 30.06.2024, then the bank guarantee of Rs. 5.00 lacs submitted by the President, Sunil Gugnani Memorial College of Education Society(Regd.) Rohtak will be forfeited and encashed. Thereafter the process for disaffiliation may be initiated against the College without any further notice.

Accordingly, a financial bank guarantee was submitted by the President concerned in this regard alongwith affidavit dated 18.08.2023 to the effect that if the College fails to submit the NOC from the NCTE regarding shifting of premises to its new location upto 30.06.2024, then the bank guarantee of Rs. 5:00 lacs will be forfeited and encashed and thereafter the process of disaffiliation may be initiated against the College without any further notice (Annexure A/96 pages 700-703, already circulated). Thereafter the College was put in 'Admission Category' for the session 2023-24 with the specific conditions.

Thereafter the above orders of the Vice-Chancellor were considered by the Academic Council vide its Reso. No. 68 of its meeting held on 27.06.2024 and resolved that the action taken by the Vice-Chancellor is ratified and recommended to the Executive Council for its consideration (Annexure A/97 page 704, already circulated). Accordingly, the Executive Council vide its Reso. No. 18(26) of its meeting dated 29.06.2024 has resolved that the recommendations of the Academic Council as above be approved (Annexure A/98 page 705, already circulated).

As per E.C. Reso. No. 18(26) dated 26.06.2024, the above College was required to submit the permission from the Apex body i.e. NCTE to the University upto 30.06.2024. But due to non-submission of NOC/shifting permission from the NCTE within stipulated period, in terms of above E.C. Resolution, the bank guarantee was forfeited and as such the College was also put in 'No Admission Category' for the session 2024-25 intimating that the process for disaffiliation is also being initiated against the College vide office letter dated 30.08.2024 (Annexure A/99 page 706, already circulated). It is also clarified that the permission/ shifting orders are being issued by the NCTE for example the University has received permission/shifting orders in respect of 02 other Colleges i.e. I.P.S. College of Education Research and Technology, Nehru Colony, Rohtak and Kirti College of Education, Village Anayat, Tehsil Gohana, Distt. Sonapat (Annexure A/100 pages 707-711, already circulated). However, aggrieved with the letter dated 30.08.2024 (Annexed above), the President, Sunil Gugnani Memorial College of Education for Girls, Rohtak filed Civil Suite(CS) in the Hon'ble Court of Sh. Manglesh Kumar Choubey, Civil Judge(Sr. Divn.) Rohtak against the University decision conveyed vide letter dated 30.08.2024 and after considering the case, the Hon'ble Court of Sh. Manglesh Kumar Choubey, Civil Judge(Sr. Divn.) Rohtak passed orders dated 10.10.2024 and relevant part of which is reproduced as under:

..... "The injunction application is partly allowed. Implementation of the order dated 30.08.2024 is stayed till the time the NCTE decides the application of plaintiff on merit. The defendant No. 1 is directed to immediately put the plaintiff-college in 'admission category' for the current Session 2024-25. The College will be at liberty to get admission of students in accordance with the existing rules whether or not the period for online application has expired. If such period has expired and there is no other lawful method to accept students, the defendant No. 1 will be the winner and it will not suffer any loss. The defendant No. 1 is not going to infringe any rule or regulation by putting the college to 'admission category' and letting the NCTE perform its legal duties."

Aggrieved with the orders of the Hon'ble Court of Sh. Manglesh Kumar Choubey, Civil Judge (Sr. Divn.) Rohtak dated 10.10.2024, the University preferred an appeal before District Judge, Rohtak and same was dismissed by the Hon'ble Court of Sh. Kapil Rathi, Additional District Judge, Rohtak on 14.11.2024 and thereupon, the University preferred Civil Revision against the Judgment dated 14.11.2024 and same is pending before the Hon'ble High Court, Chandigarh by way of CR No. 327 of 2025.

In the meanwhile, as the admission process for the session 2025-26 was going to start, hence, the said College was again asked to submit the requisite permission of the NCTE regarding shifting of premises within a week otherwise the said College will be placed in 'No Admission Category' for the session 2025-26 as conveyed vide this office letter No. CB-IX/2025/9074 dated 04.07.2025 (Annexure A/101 page 712, already circulated). As the College had failed to submit the requisite permission of the NCTE, New Delhi, therefore, the matter was considered by the Vice-Chancellor and in terms of orders passed, the College Sunil Gugnani Memorial College of Education for Girls, Rohtak was placed in 'No Admission Category' for the session 2025-26 and the status of College w.r.t. admission to B.Ed. program is subject to the final outcome of the Court case in the Hon'ble Pb. &Hry. High Court at Chandigarh conveyed vide this office letter No. CB-IX/F-940/2025/9557 dated 16.07.2025 (Annexure A/102 pages 713-714, already circulated). The Vice-Chancellor has also ordered that the matter be reported to Academic Council.

The Academic Council vide Reso. No. 61 in its meeting held on 02.09.2025 considered the above and passed the following resolution:

RESOLVED THAT THE ACTION TAKEN BY THE VICE-CHANCELLOR AS ABOVE BE APPROVED AND RECOMMENDED TO THE EXECUTIVE COUNCIL FOR RATIFIED.

The Executive Council considered the above; and

RESOLVED THAT THE RECOMMENDATIONS OF THE ACADEMIC COUNCIL AS ABOVE BE APPROVED AS ONE TIME EXCEPTION.
