In this connection, it is to inform you that your request regarding disaffiliation/closure of College i.e Sanskaram Degree College, Kheri-Taluka, Patauda, Jhajjar has been considered by the Academic Council vide Reso No.37 dated 02.09.2025 and resolved as under:

"Resolved that the request of the Chairman, Master Dayanand Memorial Education Trust, Jhajjar for Discontinuation/Closure of Collegei.e Sanskaram Degree College, Kheri-Taluka, Patauda, Jhajjar for/from the session 2025-26 be recommended to the Executive Council for consideration and approval."

Further, the above recommendations of the Academic Council have also been approved by the Executive Council vide Reso. No.10 (19) in its meeting held on 29.09.2025 (copy enclosed) with the following conditions:-

- In the case of discontinuation of the college, it shall be incumbent upon the a) governing body of the institution concerned to give a notice of one year to its employees regarding termination of the services, which will taken effect only if and when the permission is granted by the University and subject to the condition, if any imposed by it.
- The discontinuation in respect of college shall be in stages/phase manner as b) under:
 - In the first year, admission to Part-I class will be discontinued and I) admission for Part-II, III will continue
 - In the 2nd year, admission to part-II class will be dis-continued and 11.) admission for part-III if any, will continue.
 - In the 3rd year, there may be no admission. HI)
