
ADVISORY

In view of the heavy rainfall being experienced in the district in last few days and the possibility of water-logging in certain areas, all higher educational institutions are hereby advised to remain cautious and adopt preventive measures for the safety of students, staff and infrastructure.

Institutions are requested to kindly ensure the following:

1. **Monitoring of Local Conditions:** Remain alert to rainfall and water-logging in and around the institution premises, and take timely preventive action to avoid disruption.
2. **Reporting of Emergencies:** In case water-logging or related issues obstruct normal functioning, create safety risks, or cause serious difficulties in transportation, the matter may be immediately brought to the notice of the undersigned or the District Control Room for further guidance.
3. **Closure of Institution:** In situations where closure of the institution becomes necessary due to local conditions, the matter must be promptly apprised to the undersigned for appropriate decision and approval as per guidelines.
4. **Building Safety:** No classes or gatherings should be held in unsafe, water-logged, or structurally weak areas of the institution premises.
5. **Academic Continuity:** Wherever feasible, explore the option of conducting academic activities through online mode or other suitable alternatives to avoid academic loss.
6. **Preparedness & Cooperation:** Ensure that all precautionary measures are taken in advance, and extend full cooperation with the District Administration so that safety, preparedness and uninterrupted education can be maintained.


This advisory is issued in public interest. Your proactive support is solicited to ensure the safety and well-being of all concerned during this period of excessive rainfall.
