This is with reference to your letter no. MDU/VC/193, dated 7th April 2025, addressed to Director, NAAC, regarding permission for MBGL accreditation in Cycle-4 and extension of validity of NAAC accreditation.

Maharshi Dayanand University, Rohtak-124001, Haryana is Cycle-3 accredited with "A+ Grade and 3.44" CGPA out of 4.00 valid from 28th March 2019 to 27th March 2024.

As per RAF, the University has to apply Institutional Information for Quality Assessment (IIQA) for Cycle-4 after 27th September 2023 but on or before 27th March 2024, in order to continue the accreditation of Cycle-3, as per the NAAC Institutional Accreditation Manual for Self Study Report for Universities, page number 33, X. Subsequent Cycles of Accreditation under Section A: Guidelines for Assessment and Accreditation which states hereunder

"Institutions intending to be assessed to continue their accreditation need to apply afresh by submission of A&A application during the last six months of their validity period."

The University didn't apply online Cycle-4 IIQA on or before 27th March 2024, therefore Cycle-3 accreditation cannot be extended, till the Cycle-4 accreditation.

As per NAAC Reforms 2024: Important Announcement- dated 29th June 2024.

..... 2) HEIs with valid accreditation as per the present RAF whose validity is expiring between 1st July 2024 and date of launch of Maturity Based Graded Levels (MBGL) shall be extended for a maximum period of three months after the launch of MBGL.

Maharshi Dayanand University, Rohtak, does not hold the valid accreditation as on 1st July 2024, hence Cycle-3 accreditation with "A+ Grade and 3.44" CGPA cannot be extended for a maximum period of three months after the launch of MBGL Accreditation.

However, Maharshi Dayanand University, Rohtak, may kindly volunteer for Cycle-4 A&A in the Basic (Binary) Accreditation Framework (BAF)/MBGL Accreditation as and when it is launched.
