Ratification of the action taken by the Vice-Chancellor, in anticipation approval of the Academic Council, in approving the recommendations of the PGBOS in Genetic in its meeting dated 05.06.2025, PGBOS in Music in its meeting dated 19.03.2025 & PGBOS in Biochemistry in its meeting dated 08.02.2025 regarding changes in Eligibility Criteria in one year PG Diploma in Genetic Counselling, M.A. Music (Vocal) & M.A. Music (Instrumental-Sitar) and M.Sc. (Biochemistry).

The PGBOS in Genetics considered and recommended the revised Eligibility Criteria for admission to 01-Year PG Diploma in Genetic Counselling in its meeting held on 05.06.2025 (**Annexure A/30 page 417, already circulated**).

The PGBOS in Music vide Resolution No.01 of its meeting held on 19.03.2025 considered and approved the revised the Eligibility Criteria for admission to M.A. Music (Vocal) and M.A. Music (Instrumental-Sitar) (**Annexure A/31 pages 418-419, already circulated**).

The PGBOS in Biochemistry vide Resolution No.02 of its meeting held on 08.02.2025 considered and recommended the revised the Eligibility Criteria for admission to M.Sc. (Biochemistry) w.e.f. the session 2025-26 (**Annexure A/32 pages 420-423, already circulated**).


