1. TO CONSIDER THE MATTER WITH REGARD TO MAINTAIN GAP YEAR AND ADMISSION OF MR. ANKIT, STUDENT OF B.A. ENGLISH (4 YEAR), DEPARTMENT OF ENGLISH AND FOREIGN LANGUAGES, M.D.UNIVERSITY, ROHTAK.

CONSIDERED THE ABOVE REQUEST OF MR. ANKIT AND RESOLVED THAT THE REQUEST OF THE STUDENT MAY NOT BE ACCDED TO IN THE LIGHT OF CLAUSE-11(ii) OF COMMON ORDINANCE OF 4- YEAR PROGRAMMES (SEMESTER SYSTEM).

2. To consider the representation dated 16.03.2026 received from the students of PG Diploma in Translation (English-Hindi-English) in the Department of Hindi with regard to exemption from paying late fees for submission of Dissertation and forwarding the same to the Secrecy Branch, MDU, Rohtak
