Important Note:- 1.The actual date of practical examinations will be fixed by the College/Institution in consultation with Co-ordinator/Head Examiner within the above schedule and the same will be notified by the Colleges to their respective regular/re-appear students, under intimation to this office.

2. Those Education Colleges have been transferred in Gurugram University and their re-appear practical examinations of M.Ed will be conducted at Ch. Partap Singh Memorial College of Education, Gurugram.

The appointment of the Practical Examiners shall be made by the University. The Practical examinations shall be conducted judiciously as per above schedule. After conducting the Practical examinations, the convened colleges shall be required to upload the marks awarded by the Examiner(s) on the University portal latest by 22.09.2026.

The College concerned shall also submit Original forwarding memo and List of Practical Awards complete in all respects i.e. having details of total present and absent students, full signature and complete address of the Practical External Examiners with contact No. along with soft copy of the videography done, to the In-charge (Conduct), M.D.University, Rothak, within further seven days after uploading the External Practical Awards latest by 29.09.2026, falling which late fee will be charged from the College concerned as per University Rules.

- The Practical Examinations of Re-appear students shall be conducted in their respective Colleges of which they were regular students.**
- While submitting TA/DA Bills, the Practical Examiner must be required to clearly mention their full name, designation with Grade Pay, Name of College, Contact no., Name of Course with Semester and Session and the same may be submitted to the Accounts Branch of the University directly;
- IT IS MANDATORY FOR THE COLLEGES TO CONDUCT VIDEOGRAPHY OF PRACTICAL EXAMS AT THEIR OWN LEVEL AND EXPENDITURE FOR THE SAME WILL BE BORNE BY THE CONCERNED COLLEGE/INSTITUTE ITSELF.**
