

2. Noted the follow up action of the previous meeting of the Faculty of Humanities & Arts held on 20.06.2024 (Annexure-II, Page-11).
3. To ratify the action taken by the Vice-Chancellor in approving the Scheme of Examination and Syllabus of various UG/PG Programs under the Faculty of Humanities & Arts in anticipation of the



approval of Faculty of Humanities & Arts and Academic Council from the session 2025-26 (Annexure – A-III, Page - 15)

The Vice-Chancellor allowed for uploading the Syllabi/Scheme of Examinations of pending courses/semesters of UG/PG Programs and also allowed for uploading the already finalized Scheme/Syllabi with incorporation of formative assessment provisions in anticipation of approval of Faculty of concerned/Academic Council as the classes for UG and PG Programs were scheduled to start from 15.07.2025 and 28.07.2025 respectively.

Accordingly, the syllabus and Scheme of Examinations of all UG/PG Program courses under the Faculty of Humanities & Arts had been got uploaded on the University Website after vetting the same from the Director, IQAC, as per the Formative Assessment Models w.e.f 2025-26 as provided by the concerned Head/Director of the Department.
