27. Consideration of payment of the sitting fee of ₹5000/- plus TA/DA to the University nominee/ representative (to be paid by the Colleges/Institutes) for attending the meeting of the Governing Body/Board of Governors/Enquiry Committees in Colleges/Institutes affiliated with this University on the analogy of norms as prescribed by the Executive Council vide Resolution No. 44 dated 31.12.2021.

Earlier the Academic Council vide Resolution No. 39 of its meeting held on 28.12.2021 has considered the recommendations of the Committee regarding re-visiting guidelines/ instructions for conduct of election of the Governing Body/Board of Governors of Govt. Aided Private and SFS Degree, Education.

Architecture and Law Colleges and resolved that the matter be recommended to the Executive Council for consideration and approval. The point No. 17 of these guidelines/instructions states that:

"Seating fee of Rs. 5000/- and TA/DA as per University Rules shall be paid by the Institute/College to the University Observer for each visit".

Further, the Executive Council vide Resolution No. 44 of its meeting held on 31.12.2021 resolved and approved the above recommendations of the Academic Council.

As there is/was no provision for paying seating fee to the University nominee/ representative for attending the meeting of the Governing Body/Board of Governors/Enquiry Committee in Colleges/Institutes affiliated with this University. Therefore, an office proposal was submitted to the Vice-Chancellor to consider and allow payment of ₹5000/- plus TA/DA to the University nominee/representative (to be paid by the Colleges/Institutes) for attending the meeting of the Governing Body/Board of Governors/Enquiry Committee in Colleges/Institutes affiliated with this University on the analogy of norms as prescribed by the Executive Council vide Resolution No. 44 dated 31.12.2021.

The Vice-Chancellor has ordered to refer the matter to the Executive Council for consideration and approval.

The Executive Council considered the above; and
