(Sharp) on 03.08.2026 (Monday) for admission in M.A. HISTORY program. The counselling shall start at 11.00 A.M., However, in case of candidate(s) reporting after 11.00 A.M. shall be considered for counselling as per the availability of seats at that time.**
3. Candidates have to appear physically in the counselling for admission. They are required to submit 2 sets of self attested copies of their all documents/testimonials as mentioned in the prospectus along with original in the Deptt. of History and Archaeology, MDU Rohtak.
4. Candidates are required to deposit fee online (Debit Card/Net Banking only) up to **04.08.2026**, failing which their candidature will stand automatically cancelled, and the seat will be offered to next candidate in merit list.
