Chandigarh: House meet deferred amid standoff in civic body

Chandigarh, Mar 27
 The Chandigarh House of Representatives (HoR) meeting scheduled for today has been deferred due to a deadlock in the Chandigarh Municipal Corporation (CMC) over the proposed budget for the current financial year. The HoR, which is the legislative body of the city, is currently in a stalemate with the CMC over the proposed budget for the current financial year. The CMC has proposed a budget of Rs 1,000 crore, which is significantly higher than the previous year's budget of Rs 800 crore. The HoR members are concerned about the increase in expenditure and the impact on the city's economy. They are demanding a more realistic budget that takes into account the city's financial constraints. The CMC, on the other hand, is insisting on the proposed budget, arguing that it is necessary for the city's development and infrastructure projects. The meeting is expected to resume once the deadlock is resolved.
