1.	Online submission of the Registration Return/ Continuation Return and generating Challan for depositing fees without late fees in respect of OTMIL Courses (UG, PG)	Up to 13.03.2026
2.	Submission of Hard Copy of the Registration Return/Continuation Return in R&S Branch alongwith required Certificates/Documents without late fees	Up to 16.03.2026

If a College/Institute fails to submit the documents/certificates alongwith the Hard Copy of RR, the late fee as under will be charged as per prescribed schedule:

- (i) For 1-30 days late after the expiry of due date: Rs.500/- per student
- ii) For 31-45 days late after the expiry of due date: Rs.1000/- per student
- iii) For 46-60 days late after the expiry of due date: Rs.2000/- per student
- iv) For one week before commencement of examination Rs.3000/- with the permission of Vice-Chancellor and after that no request will be considered under any circumstances.
