**Sub: Provisional Affiliation for establishment of a new Law College in the name and style of "Sat Kabir College of Law", Village Ladrawan, Dist. Jhajjar for running LLB (Hons)-3 Year with an intake of 120 seats and BALLB (Hons)-5 Year with an intake of 60 seats for/from the session 2026-27 subject to approval of Bar Council of India (BCI), New Delhi.**

This is with reference to your request/proposal dated 30.03.2026 regarding establishment of new Law College in the name and style of **Sat Kabir College of Law, Village Ladrawan, Distt. Jhajjar** on the subject cited above.

On the basis of recommendations of the Inspection Committee, the Vice-Chancellor, in anticipation of approval of the Academic Council/Executive Council, has been pleased to grant provisional affiliation for establishment of new Law College in the name & style of **Sat Kabir College of Law, Village Ladrawan, Distt. Jhajjar** for running LLB (Hons)-3 Year with an intake of 120 seats and BALLB (Hons)-5 Year with an intake of 60 seats for/from the session 2026-27.

The above provisional affiliation is granted subject to approval of the Academic Council/Executive Council, Central Body i.e. Bar Council of India, New Delhi and fulfilment of all the observations/shortcomings pointed out by the Inspection Committee in its report dated 09.05.2026 (copy enclosed). The admissions to the said programs shall be made through the competent authority of the College/Institute by following the schedule of admission prescribed by the University only after the receipt of approval from Bar Council of India, New Delhi. Further, the above provisional affiliation is granted subject to fulfilment of the following mandatory conditions:-

1. The College shall constitute Governing Body as per Central Body/University norms.
2. The admissions should not exceed beyond the sanctioned intake.
3. The College shall submit the OC (Occupation Certificate) duly issued by the District Town & Country Planning, Haryana to be earmarked for Law College within two months.
4. The teaching and all other staff shall be appointed through properly constituted Selection Committee and with prior approval of the University. CPF scheme must be introduced. Service rules for teaching/non-teaching staff should be framed and a copy of the same be sent to the University.
5. The faculty shall be appointed in the pay scales prescribed by Central Body/BCI/University norms from time to time.
6. The fee structure prescribed by the State Government/University shall be strictly followed.
7. All academic, physical and other infrastructural facilities to be provided by the institute as prescribed by the Central Body/University from time to time shall be continued/upgraded.
8. The institute shall furnish requisite documents/information as required by the University from time to time in order to ensure proper maintenance of the infrastructural facilities and academic standards.
9. The information furnished in respect of above programs shall be factual and correct. In the event of any information found to be false, misleading or suppressed, the provisional affiliation shall be withdrawn by the University without any notice.
10. In the event of non compliance of the University Act/Statutes/Ordinance/Rules and Regulations and any other instructions/guidelines issued from time to time, the University shall be free to withdraw the provisional affiliation and all liabilities arising out of such a withdrawal would solely lie on the concerned society/institute.

11. The institute shall follow the mode of selection of candidates for admissions as approved by the Central Body/State Government/University.
  12. The institute shall provide all Academic and Infrastructural facilities including classrooms, hostels, library, laboratories, workshops, play grounds and other amenities required for the smooth conduct of its affairs as per Central Body/BCI/University Norms.
  13. The Trust/ Society shall not change the location of the Institute without prior approval of the Central Body/University.
  14. **Building:** The entire building of the College will be at the disposal of the Controller of Examinations for the purpose of Conduct of examinations as and when, Examination Centre is created (for the theory and practical both), it will be obligatory for the Principal to provide necessary infrastructure for smooth conduct of examination.
  15. **Examination Centre:** Creation of an Examination Centre in the College will be at the discretion of the Controller of Examinations. The Centre of examinations for the students studying in the College can be shifted to any other College. In such a situation, it will be the responsibility of the institution to make arrangements for transporting the students to the Centre of Examinations without any extra charges from the students. Similarly, the University can also shift the students of other Colleges/Institutes to the College/Institution under reference for which necessary infrastructure will have to be provided by the Principal concerned.
  16. **Staff:** For the purpose of conduct of examinations, the services of entire teaching and non-teaching staff will be at the disposal of the Controller of Examinations. The examination duties can be assigned to any member of teaching and non-teaching staff for the smooth conduct of examinations.
  17. **Strong Room:** There will be a strong Room in the College at the prime location adjacent to the office of the Principal to keep the confidential material of the University as and when required. The Strong Room will essentially have double lock system.

You are, therefore, requested to complete the above requirements/conditions and send compliance report of the same to the University at the earliest so that further action may be taken accordingly. In case of non compliance of above conditions/ requirements, the University shall have the right to refuse the extension of provisional affiliation to the institute for the next academic session 2027-28.
